1. **BADV-14/012-A.** Block #16, Lot #8. Commonly known as 2 Park Street, Edgewater, NJ. Applicant: Arman Torosian. Request to construct a new single family residential development. Deemed complete on July 6, 2016.
2. **BADV-16/006.** Block74, Lot #1.01. Commonly known as 700 River Road, Edgewater, NJ. Applicant: AvalonBay Communities, Inc. Request to seek amended site plan approval to reconstruct the apartment building that was destroyed by fire. Deemed complete on July 6, 2016.
3. **BADV-16/004.** Block #73, Lot #5. Commonly known as 16 Oakdene Terrace, Edgewater, NJ. Applicant: Premier Developers, LLC. Request for reconsideration and otherwise allow the applicant to more thoroughly explain and present the additional information in the revisions and plan amendment which relate to the height of the proposed duplex building.
