ORDINANCE NO. 2026-001

AN ORDINANCE REPEAL AND REPLACE ARTICLE II, ICE AND SNOW REMOVAL, CHAPTER 380-19, SECTION A, TITLED “VIOLATIONS AND PENALTIES; REMOVAL BY BOROUGH; COST TO LIEN” OF THE CODE OF THE BOROUGH OF EDGEWATER

BE IT ORDAINED: BY THE MAYOR AND COUNCIL OF THE BOROUGH OF EDGEWATER AS FOLLOWS: REPEAL AND REPLACE ARTICLE II, ICE AND SNOW REMOVAL CHAPTER 380-19, SECTION A, TITLED “Violations and Penalties; removal by Borough; cost to lien” OF THE CODE OF THE BOROUGH OF EDGEWATER:

SECTION 1.

Chapter 380-19, Section A “Violations and Penalties; removal by Borough; cost to lien” SHALL BE REPEALED: Section A. In addition to the penalties provided in Subsection B of this section, any person violating or failing to comply with any of the provisions of this article shall, upon conviction thereof, be punishable by a fine of \$50 for the first offense, \$100 for the second offense, and \$150 for a third or subsequent offense. The continuation of any such violation for each successive day shall constitute a separate offense.

SECTION 2.

Chapter 380-19, Section A “Violations and Penalties; removal by Borough; cost to lien” SHALL BE REPLACED: Section A. Any property owner, property manager, or contractor found in violation of Article II, Ice and Snow Removal, Chapter(s) 380-17, 380-18, shall be issued a summons for the violation by either the Edgewater Police, Edgewater Building Department, or any designated Code Enforcement Officer of the Borough of Edgewater. One violation shall be issued for each 24-hour period of non-compliance, a continuation of any such violation for each successive day shall constitute a separate offense. Each violation shall be in the amount of \$500.00 payable to the Borough of Edgewater Violations Bureau of the Municipal Court.

SECTION 3.

Effective Date.

This ordinance shall take effect immediately upon final publication as required by law.

SECTION 4.

Repeal of Inconsistent Ordinances.

All ordinances and parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
