OPEN PUBLIC MEETING ACT

Mayor Delaney read the Open Public Meetings Act Statement into the Record.

MOMENT OF SILENCE

Mayor Delaney asked for a moment of silence and remembered Barbara Quinton.

SALUTE TO FLAG

Councilman Doran led the Pledge of Allegiance.

CONFERENCE

- 1. Tim Corriston Connell Foley, Special Counsel gave update on legal issues with TERMS. Noted State Court Action is over. Updated Federal action. Reviewed TERMS counterclaim. Borough's position is that TERMS did not live up to its obligations under the contract. Will aggressively pursue TERMS for being responsible as the gate keeper of the field. Spoke about Alcoa and automatic extension. Agreement between Waterside and Alcoa. Waterside- extensive testing as necessary to prove that material came from Alcoa. Hopeful that once investigation is finished can sit with Waterside and resolve issue.
- 2. Tom Bambricck First Environment, Environmental Consultants Present to give status report. Almost completed remediation in north of park 95% done. Making recommendations. To date, some 8,000 tons have been remediated.
- 3. Mike Neglia Neglia Engineering Associates, Site Engineer –Administrator referenced Resolutions 2014-267 and 269 and Little League proposal. To keep the project moving forward Governing Body has to make decisions. First decision is putting grass or turf on the Little League field. No work can begin on amenities until field is remediated. Spoke about anticipated goals. Anticipated goal schedule for 1st Phase of the remediation project is the end of January. Governing Body has to begin thinking about amenities. Spoke about bids. Responded to questions from Governing Body. included the playground, the basketball courts and tennis courts. Spoke about drainage. Explained why he recommended not opening up sections of the big park. Should wait for the big park to be completed. Responded to questions.

- Explained how, in his opinion, sod with underground sprinklers could be put in certain sections.
- Explained changes because of Green Acres funding.

Sheldon Gellman, 37 Hooks Lane:

• Referenced the language in one of the paragraphs of the Resolution for the Little League Field.

1515-2014 An Ordinance Amending and Supplementing chapter 282, "Parking Lots," Article II, "Shadyside," to Regulate the Issuance of Employee and Resident Parking Permits for Certain Municipal Lots in the Borough of Edgewater

The Clerk read the Notice of Ordinance and Ordinance No. 1515-2014.

Notice is hereby given that the following proposed Ordinance was introduced at a meeting of the Mayor and Council of the Borough of Edgewater, State of New Jersey held on the 20th day of October, 2014 and given its first reading, and the same was then ordered to be published according to law, and that said Ordinance will be further considered for final reading and adoption at a meeting of the said Mayor and Council to be held in the Nancy Merse Council Chambers, 55 River Road, Borough of Edgewater, New Jersey on the 10th day of November, 2014 at 7:00 pm or as soon thereafter that the matter can be reached, at which time and place all persons interested will have an opportunity to be heard concerning said Ordinance.

The said Ordinance is as follows:

BOROUGH OF EDGEWATER ORDINANCE NO. 1515-2014

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 282, "PARKING LOTS," ARTICLE II, "SHADYSIDE," TO REGULATE THE ISSUANCE OF EMPLOYEE AND RESIDENT PARKING PERMITS FOR CERTAIN MUNICIPAL LOTS IN THE BOROUGH OF EDGEWATER

WHEREAS, the Borough of Edgewater currently owns and maintains two parking lots in the Shadyside district along Old River Road, known colloquially as the "North Lot" and the "South Lot," which are comprised of certain real property located in Block 85.01, being portions of Lots 2 or 2.01, and a portion of Lot 1.01 in Block 91, along with certain property in Block 91, portions of Lots 1.01 and 1.02 used for landscaping purposes, the specifics of which are set forth in and subject to the provisions of an agreement dated April 21, 1995 (the "Agreement") between the Borough of Edgewater and various other parties thereto; and

WHEREAS, the parking provided in the North Lot and the South Lot is intended to be used exclusively for residents of the Shadyside district, along with owners, employees and customers of businesses in the Shadyside district, and commuter parking is prohibited in accordance with the Agreement and is otherwise limited to a period of no longer than four (4) hours; and

WHEREAS, it has come to the attention of the Mayor and Council that parking spaces in the North Lot and the South Lot are frequently being used by commuters for periods in excess of four (4) hours, which significantly and detrimentally limits the parking available for the intended beneficiaries of the parking facilities provided by the North Lot and the South Lot; and

WHEREAS, the Mayor and Council, in consultation with the Police Department of the Borough of Edgewater and residents and businesses in the Shadyside district, are desirous of amending the parking regulations for the North Lot and the South Lot to:

1) provide dedicated employee parking at the northern end of the North Lot for use by the employees of businesses located in Shadyside;

- provide for the issuance of separate resident and employee stickers to assist the Police Department in enforcing parking regulations in the North Lot and the South Lot; and
- 3) change the regulations concerning metered parking in the South Lot to reduce the permitted maximum parking time from four (4) hours to two (2) hours.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Edgewater, County of Bergen, State of New Jersey, as follows:

Section 1. Chapter 282, "Parking Lots," Article II, "Shadyside," Section 282-9 of the Code of the Borough of Edgewater is hereby amended and supplemented by adding the <u>underlined</u> text and deleting the [bracketed] text, as follows:

§ 282-9. Obligations of Borough.

The Borough shall be obligated to undertake, maintain and keep in good repair the parking facilities described in § 282-8 [285-8], and to remove therefrom snow and ice, to periodically provide stripping, to maintain, repair and replace when necessary the curbing and macadam, to maintain and replace when necessary landscaping, to remove trash and debris and to maintain and replace when necessary the lighting fixtures and light bulbs.

<u>Section 2.</u> Chapter 282, "Parking Lots," Article II, "Shadyside," Section 282-11 of the Code of the Borough of Edgewater is hereby amended and supplemented by adding the <u>underlined</u> text and deleting the [bracketed] text, as follows:

§ 282-11. Regulations governing use.

A. Lots defined.

- 1. North Lot. Located on Block 85.01, portions of Lots 2 and 2.01; situated north of Thompson Lane between River Road and Old River Road (ORR), and includes the angled parking on the east side of ORR, between the northerly and southerly driveways into the lot. A portion of the North Lot shall be reserved for "designated employee parking" as defined and regulated herein.
- 2. South Lot. Located on Block 91, a portion of Lot 1.01; situated south of Thompson Lane, along the east side of ORR, consisting of 39 perpendicular parking spaces, said spaces divided 28 to the north of the driveway into the project known as One Hudson Park, and 11 south of said driveway along the Westerly Wall of One Hudson Park.

B. Time limits.

- 1. North Lot. No vehicle shall be parked in the North Lot for a period of more than four (4) consecutive hours, except as otherwise permitted by this Article.
- 2. South Lot. No vehicle shall be parked in the South Lot for a period of more than two (2) consecutive hours, except as otherwise permitted by this Article.

C. Special parking stickers.

1. Residential stickers. Any person residing within Block 90, along the west side of ORR, beginning on the north with Lots 38 - 42, street addresses 272-276 ORR, and ending on the south with and including Lot 17, street address 236 ORR who does not have access to on-site parking may obtain a special residential parking sticker from the Borough, which will permit such person to park the vehicle for which it has been issued without

- fee and for a period longer than the time limitations set forth in this section in either the South Lot or in the North Lot, excluding the area reserved for designated employee parking.
- 2. Employee stickers. Individuals employed by businesses located along the west side of ORR, beginning on the north with Block 88, Lot 9, street address 300 ORR and ending on the south with and including Block 90, Lot 17, street address 236 ORR, may obtain a special employee parking sticker from the Borough, which will permit such person to park the vehicle for which the sticker has been issued for a period longer than the time limitations set forth in this section in the North Lot designated employee parking area only. An employee sticker shall not permit parking in either the North Lot or the South Lot in an area not marked as designated employee parking without complying with the meter and time restrictions generally applicable to all vehicles.
- 3. Regulations applicable to all stickers. There shall be no fee for issuance of a parking sticker. A sticker shall be utilized only on the vehicle for which it was issued and shall contain the registered license plate number for the vehicle. The sticker shall be conspicuously displayed on either a window or the rear bumper of the vehicle. A sticker shall not be transferable to another individual or vehicle, except as permitted herein. It is the obligation of a sticker holder to notify the Borough Clerk should the resident change vehicles or the license plate of said vehicle. Failure to notify the Borough Clerk may result in a ticket being issued for violation of this Ordinance.
- D. Designated employee parking. Spaces designated in the northernmost portion of the North Lot shall be reserved for designated employee parking for vehicles bearing employee stickers issued pursuant to this Article. The number of spaces designated as set forth above shall be adjusted from time-to-time as determined by the authorized municipal agency, as may be designated by resolution of the Governing Body, after taking into account demand for employee parking. The spaces so designated shall be painted and appropriate signage shall be provided. There shall be a fee of one dollar (\$1.00) per day to park in the designated employee parking area.
- E. <u>Street parking</u>. <u>Neither a residential sticker nor an employee sticker shall permit any on-street parking without complying with the meter and time restrictions generally applicable to all vehicles.</u>
- F. Meters. Meters are hereby authorized to be placed in the North Lot and the South Lot reflecting the time limitations set forth herein.
- G. Applicability. The time limitations and other regulations set forth in this Article shall be in effect daily from 7:00 a.m. to 9:00 p.m.

[The parking of vehicles within the parking areas set forth in this article shall be limited to a period of no more than four consecutive hours. Notwithstanding this limitation, any person residing within Block 90 or on Lots 9 and 11 in Block 88, any person owning a business within said area or any employee of a business within said area may park within such parking facilities for a period longer than four hours, provided that such person has obtained a parking permit from the Police Department of the Borough of Edgewater.]

Section 3. Severability.

If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated and shall remain in full force and effect.

Section 4. Effective date.

This Ordinance shall become effective immediately upon final passage and publication as required by law.

Section 5. Repeal of inconsistent ordinances.

All ordinances and parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
